Warm regards from Aurora's PG College (MCA)!

We greatly value our partnership with Osmania University and commend the efforts made to deliver quality education through a well-structured curriculum.

During a recent Student Exit Survey conducted at our institution, feedback from MBA and MCA students highlighted specific areas in the curriculum that could be improved to better meet their academic and professional needs. The concerns raised focused on:

- **Emphasising Ethical and Professional Conduct:** A call for greater focus on ethical decision-making and professional behaviour.
- **Improving Communication Skills:** A demand for enhanced training in verbal and written communication tailored to professional settings.
- **Promoting Research and Innovation:** A need for increased opportunities to engage in research and creative problem-solving.
- **Building Leadership and Teamwork Abilities:** Limited avenues to develop collaborative and leadership competencies.

In response to this feedback, we kindly propose the following recommendations for curriculum enhancements:

1. Strengthening Ethical and Professional Conduct

- Embed a dedicated module on professional ethics and corporate governance within core subjects.
- Use case studies and role-playing exercises to teach practical applications of ethical principles.
- Include assessments designed to evaluate ethical and professional decision-making.

2. Enhancing Communication Skills

- Introduce a course specifically designed to develop business-oriented communication skills.
- Include modules on public speaking, presentation techniques, and interpersonal communication, ideally in the first semester.
- Conduct evaluations through debates, group discussions, and mock interviews to build confidence and fluency.

3. Encouraging Research and Innovation

- Introduce research-focused courses and expand project-based learning modules.
- Facilitate student-faculty or industry collaborations on research initiatives.
- Incorporate topics on research methodologies, intellectual property rights (IPR), and innovation management.

4. Developing Leadership and Teamwork Abilities

- Integrate team-based capstone projects to foster collaboration and leadership.
- Add soft skills training modules focusing on teamwork and leadership development.

We are confident that implementing these changes will greatly enhance the learning experience and better equip students for future challenges.

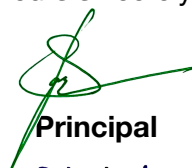

1. Implementation of Previous Suggestions:

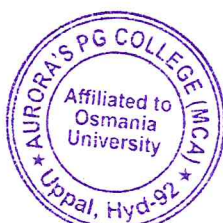
The Director provided a detailed update on the resolutions from the last meeting, outlining the actions initiated based on those discussions.

The feedback analysis report for the academic year 2023-24 was presented. All stakeholders provided good to excellent feedback across various aspects of the institution. The board appreciated the actions taken based on the feedback and suggested increasing guest lectures for the academic year 2024-25, particularly by inviting industry experts.

5. Vocational Training Programs:

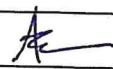
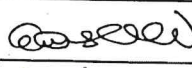
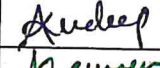
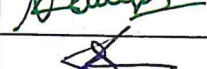
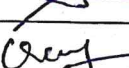
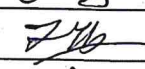

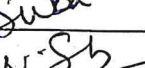
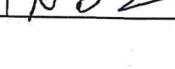

6. Feedback Analysis

Discussions:

- 1.The Governing Body members unanimously approved the minutes from the previous meeting.
- 2.The Principal introduced the sponsoring body, the Church Educational Society, as well as the management team. A brief profile of the institution was also presented. The institution is affiliated with Osmania University and is AICTE-approved, offering MBA, MCA, and Integrated MBA courses.
- 3.The Principal informed the members that the college is situated on a 0.5-acre plot, with its own building housing spacious classrooms, tutorial rooms, seminar halls, a computer center, and well-equipped computer laboratories. The college also boasts a well-stocked library, and all classrooms, seminar halls, and labs are equipped with ICT facilities.
- 4.Students are actively engaged in various clubs such as the Management Club, Yoga Club, Social Club, and Arts Club, which contribute to their overall personality development. This holistic approach has positively impacted the graduation percentages in both MBA and MCA courses, with an increase in distinctions and other academic achievements in recent years.
- 5.The students regularly visit nearby government schools, where they conduct fun games, distribute small gifts to participants, and encourage children to focus on their studies. Additionally, students run awareness programs on topics like child safety, hygiene, and gender sensitivity.



6. Due to increasing demand, the Principal proposed increasing the intake for the MCA course, which currently admits 60 students. It was also decided that the institution would explore collaborations with other institutes to offer contemporary courses that would enhance students' employability and promote entrepreneurial skills.
7. The institution is actively pursuing autonomy with the University Grants Commission (UGC). Following this, the proposal for collaboration with international universities will be considered.
8. The feedback analysis report for the academic year 2021-22 was presented, which showed that stakeholders—including students, faculty, parents, and alumni—rated all aspects of the institution (academic quality, infrastructure, faculty support, extracurricular activities, and administrative services) as good to excellent.

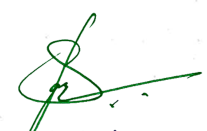

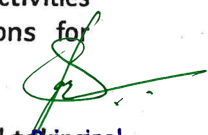

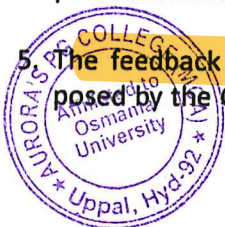
Discussions:

Discussions:

1. Conduct of Online Classes in view of COVID-19

In response to the COVID-19 pandemic, the need to transition to online education was discussed to ensure uninterrupted learning. Prof. Anil K Saxena stressed the importance of preparing both students and faculty for online classes to guarantee a smooth and effective learning experience in a virtual environment. Prof. K. Stevenson highlighted the benefits of online learning platforms, recommending the inclusion of certified courses in the curriculum to enhance skill development and employability. Dr. Jayasri Benkal proposed incorporating live projects and virtual internships to provide practical exposure to students, helping them understand real-world corporate needs.

2. Student Skills Enhancement

Prof. Saxena suggested the introduction of clubs to develop public speaking, behavioral skills, emotional intelligence, resilience, and lifestyle management. He also recommended teaching foreign languages and emphasized the importance of guiding students to cultivate the skills of conceptualization and coherent thought processes. Mr. C. Krishna Prasad stressed the need to groom students to meet the rising expectations of the corporate world, especially in managing stress. He recommended that students be encouraged to take public speaking courses.

3. Collaboration with Industry

Prof. Saxena emphasized the importance of collaborating with industries for student internships and identifying companies that offer internship opportunities. He also suggested exploring foreign collaborations to diversify training and internship experiences. Mr. Krishna Prasad stressed the value of student participation in industry collaborations, as it fosters ownership, a key quality the corporate world values. Dr. Jayasri Benkal proposed

collaborations with prestigious institutions such as IISc, Bangalore, and IIIT, Hyderabad for mentorship and training, especially for startups, and recommended that students participate in short-term training programs provided by corporate entities.

4. Entrepreneurship Development

Prof. A.K. Saxena highlighted the importance of internships to foster successful ventures. The Principal provided an overview of the Entrepreneurship Development Cell and its programs aimed at promoting entrepreneurship among students. The MBA II-year students had attended a one-week training program on entrepreneurship conducted by NIMSE. The college also organizes guest lectures by industry professionals on topics like startups and financing.

5. Student Progression

It was decided to establish various clubs to promote holistic student development. Interactive teaching methods, such as role plays, case studies, debates, seminars, and group discussions on contemporary business scenarios, were recommended. The Principal emphasized the importance of students actively participating in management events organized by other business schools, securing prizes and accolades. The Principal also shared that MCA and MBA students had secured university ranks, and over 85% of students were placed in renowned multinational corporations in the previous academic year.

6. Enhanced Service Quality

The Principal elaborated on the initiatives taken to enhance service quality. He proposed the implementation of ERP software to automate services such as library management, book issuance, fee payments, scholarships, examinations, and certificate issuance. He emphasized that the adoption of ERP would significantly reduce student wait times for accessing various services.

7. Research Promotion

The Principal highlighted the importance of research in addressing real-world societal problems and encouraged faculty members to register for PhD programs. Several faculty members have already registered and are at various stages of completing their PhDs.

8. Feedback:

The feedback analysis report for the academic year 2019-20 was presented to the members during the meeting, reflecting the institution's performance and stakeholder perspectives for the period.

9. Extension Activities

The institution regularly engages with the larger community and organized a "COVID Vaccination Drive" in collaboration with GHMC, administering approximately 1000 doses of the COVID vaccine. The students also distributed food and medicines to the needy and orphanages in the surrounding areas.

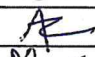

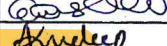
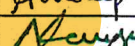

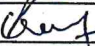
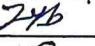

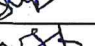
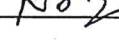
10. Additional Intake/New Course to Meet Student Demand
